DIRECTIONS FOR USE

Apply SuperSede Soybean at the rate of **2 oz per 100 lbs. of seed**. SuperSede Soybean is formulated as a ready to apply material for soybeans and other legumes including but not limited to peanuts, alfalfa, cowpeas (chickpea), dry beans, garbanzo beans, peas, lentils, pigeon peas. SuperSede Soybean is compatible with most fungicides and insecticide seed treatments. A standard jar test is recommended before use. Do not use treated seed for food, feed, or oil. Shake well before use.
